Dangers of Chemical Abortions:

A brave woman recently talked about her experience with a chemical abortion to the Supreme Court and gave an interview with The Daily Signal. Elizabeth Gillette remembers taking the pills alone in her bathroom. She told the reporter that “I found myself on the bathroom floor, covered in a pool of blood, wondering if I was going to survive the procedure, completely alone.” Elizabeth Gillette “reached down and lifted out of my body the perfectly formed transparent sac with a recognizable baby inside.” This women not only suffered physical consequences of these drugs, but also emotional consequences. She recalls, “no one told me that I would hold my child in my hands and would need to decide what to do with that body.”

What is a Chemical Abortion:

To conduct a chemical abortion a women will take two different pills. The first being mifepristone, which will allow the pregnancy to cease. Then she will take misoprostol, which will start contractions expelling the baby. These pills can be taken to end a pregnancy of up to 10 weeks' gestation. It is recorded that chemical abortions make up half of all the abortions in the United States. In my opinion, this is a staggering statistic. The goal of pro-choice advocates is to complete the abortion in the comfort and security of the mother's home or safe place. However, what was a safe place ends up being a haunting experience as these women are often completely alone. With the FDA giving the green light for these chemical abortions to be done without the supervision of a physician and Walgreens and CVS saying they will provide these drugs to women who seek them women need to be educated quickly on the dangers and life-long consequences of this decision.
