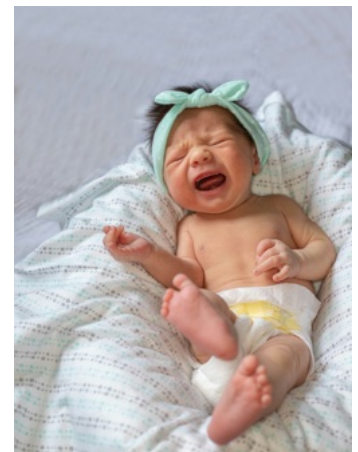

## Are These Really Performed?

How does the safest place on earth become perilous? Because of a third-trimester induction procedure! YES, this procedure is really performed. What are the details of this procedure? This abortion procedure will take place anywhere from 25 weeks of gestation to full-term. At this point in the baby's development, he or she can live outside of the womb if the mother goes into premature labor. The third-trimester induction procedure will take three or four days to complete. On the first day, the abortionist will fill a syringe with a medication called digoxin. The long needle is inserted through either the mother's abdomen or through her vagina. The abortionist aims to hit the baby's head, heart, or torso with the needle. The baby at this stage of development feels the needle being inserted into his or her body. The baby feels pain from 12-18 weeks of development. Once the abortionist injects the digoxin into the





## What's Happening?

At the end of January, President Trump signed two Executive Orders limiting the number of abortions for which the tax-payers foot the bill for. This affects both United States and overseas abortions. The Hyde Amendment, already in place since 1976, was ignored by the previous administration. President Trump's executive order reinstates the Hyde Amendment, which recognizes that taxpayers shall not pay for elective abortions. President Trump also reinstated President's Reagan's rule that "forbids foreign non-governmental organizations from funding abortions as a condition to receiving U.S. global health aid." In President Trump's first term he had "reinstated" Reagan's rule, but President Biden rescinded this rule in his term. It will be the responsibility of the Secretary of State "to ensure that U.S. taxpayer dollars do not fund organizations or programs that support or participate in the management of a program of coercive abortion or involuntary sterilization." President Trump signed these two executive orders after he and Vice President, J.D. Vance, spoke at the March for Life event.

baby he or she will die. The abortionist then takes luminary, which are sticks of seaweed, and inserts them into the mother's cervix. This allows her cervix to dilate, so she can go into labor to deliver her dead baby. On the second day, the abortionist continues to place luminary into the woman's cervix. The abortionist also conducts an ultrasound to make sure the baby is in fact dead. If the baby is still alive, the abortionist injects the baby again with a long needle and syringe filled with digoxin. The mother then continues to carry her dead baby while she waits for her cervix to dilate and labor to begin. If the woman goes into labor and cannot make it back to the clinic, she is told to deliver the baby in the toilet at home or in her hotel room. The abortionist then comes to where she is staying, takes the dead baby, and cleans up. If the woman can make it back to the clinic, she will arrive in intense labor. If the baby does not come out whole the abortionist will perform a D&E, Dilation and Evacuation. The abortionist dismembers each of the baby's body parts with clamps and forceps and removes them one by one. Once the baby and the placenta have been removed, the third-trimester induction procedure is complete.

## How Many Babies Suffer From This Procedure?

In 2023, Ohio conducted a total of 22,000 abortions! Ohio residents made up 19,229 total abortions, and the remaining 2,771 abortions were from out-of-state residents. Out of these 22,000 abortions completed, 146 of the babies were 21 weeks or older. These 146 Ohio babies, in 2023, suffered the third-trimester induction procedure. Twenty-nine of these 22,000 abortions were Hancock County residents. The past 10 years have recorded the following third-trimester induction abortions: 2023 (146), 2022 (107), 2021 (156), 2020 (113), 2019 (95), 2018 (106), 2017 (90), 2016 (140), 2015 (145), and 2014 (133). That is a total of 1,231 babies murdered by third-trimester induction abortions. The pro-death community will tell you these do not occur. That is just not the case! They absolutely do occur, and babies, mothers, and fathers all suffer as a result of these horrendous abortions procedures.
