Life Chain!

Will you pray for the end of abortion? Will you pray for those in crisis to choose life over death? Will you take an hour out of your schedule to honor the over 63 million babies who have lost their lives to abortion? I would like to introduce you to Life Chain. Life Chain is an international event that occurs throughout the United States and Canada on the first Sunday of October each year. Christians will gather for 1 hour in their communities across this land on Oct. 5th to pray from 2-3 PM for the end of abortion. Those who participate in Life Chain will line designated streets in their communities holding signs such as, "Pray to End Abortion," "Adoption the Loving Option," "Jesus Forgives & Heals," "Lord, Forgive Us and Our Nation," and "Abortion Hurts Women." While holding their sign participants will then pray individually from 2-3 PM. This is NOT corporate prayer. This IS individuals praying silently, making a statement in our community that abortion is wrong and must





What's Happening?

On Monday, August 26, Live Action News reported that a federal judge ruled Maine's abortion centers can lose their federal funding. This is a big win! One of the items in President Trump's Big Beautiful Bill designates that our tax money does NOT have to pay for abortions. In July, Maine's Family Planning organization, which also performs abortions, filed a lawsuit against losing the funding. There are currently 18 facilities in Maine that will lose this federal funding through Medicaid. "Judge Lance Walker of the U.S. District Court for the District of Maine said it was within the right of lawmakers to withhold federal money to "disassociate from conduct that is not enshrined as a constitutional right." He stated that Planned Parenthood knew that they were going to lose federal money if they continued to perform abortions, but instead of discontinuing the practice, they "stood firm in the mission." Since Planned Parenthood continued to do abortions, their federal dollars were cut off from their other services as well. This shows that their main mission is NOT women's care as they claim, but is in fact abortion. It is time that taxpayers, who know abortion is murdering children, no longer will have to pay for it, at least through this stream. Hopefully, many other states will follow. Thank you, President Trump and Thank you, Judge Walker for this big win in Maine!

come to an end. The Life organization, "Please Let Me Live" organized the first Life Chain event in 1987 in Yuba City and Marysville, California. Royce Dunn was the founder and the director of Life Chain. Dunn attended a Baptist church in Yuba City CA, and he noted the following: "Life Chain is a call to the church through pastoral leadership." Dunn's goal through organizing this event was it to be "church-oriented and pastor-focused." Through the years, Life Chain has grown and gained momentum. In 1991 there were 373 locations throughout the United Stated that organized a Life Chain event with 771,000 participants. In 1992 it grew to over 800 locations throughout the United States, and in Canada there were 97 locations that organized a Life Chain event. It was estimated in that year that 975,000 participated in the United States and 80,000 in Canada. This really is a call to action to our pastors and our church members. We need to mobilize! We need to make a peaceful statement in our communities that abortion is murder. The church can no longer look the other way. The church needs to make an impact in our own town because when the church is silent, preborn babies continue to lose their lives, and mothers are harmed, both physically and emotionally. Fathers are seldom mentioned, but abortion harms them as well. God wants His church to stand up for the voiceless. We know what is right and wrong and it is our job to influence our community and society for the better. As Christians we are God's children, as such, we should be speaking out to influence others around us. Pastor, will you take a stand in our community for Life and against abortion? Church member, will you take a stand in our community for Life and against abortion? It is TIME to bring this atrocity to an end!
